1. The **Independent State of Papua New Guinea** has received a loan from the the Asian Development Bank (ADB) towards the cost of the Town Electrification Investment Program – Tranche 1. Part of this Ioan will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB. The eligibility rules and procedures of the ADB will govern the bidding process.

2. The **PNG Power Limited** ("the Employer") invites sealed bids from qualified eligible bidders for **Ruu Creek Hydro Power Rehabilitation**, which covers the refurbishment of the two (2) hydro turbine generators (each with a capacity of 400 kW) and their auxiliaries. The works includes complete refurbishment of the electromechanical equipment as per the SBD.

3. International Competitive Bidding (ICB) will be conducted in accordance with ADB's Single-Stage: One–Envelope bidding procedure and is open to all Bidders from eligible source countries of ADB as described in Section 5 of the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this Bidding:

• Minimum average annual turnover of \$2.0 Million calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.

• Successfully completed as main supplier within the last five (5) years, at least two (2) contracts each valued at US\$ 0.6milion with nature and complexity similar to the Schedule of Supply

• Demonstrate that the goods offered have been in production for at least ten (10) years and sold a minimum of five (5) units of similar type and specification over the last ten (10) years;

The qualification criteria are more completely described in the bidding document.
